Approval of Minutes

Copies of the minutes from the February 16th, 2021, meeting were not available currently. They will be reviewed in the next meeting for approval.

Old Board Business

- a. Executive Director Rachel Dickinson updated the Board on status of complaints. There are currently two (2) pending complaints.
- b. Nicole DeLee made a motion to accept approval of new licenses issued since the last Board meeting. Dr. Bob McKinney seconded the motion. The motion passed unanimously.

New Board Business

- a. No Board members have been invited to speak at a conference or program.
- b. Rachel Dickinson provided the Board with a Finance Report Update. The Board's finances are in good standing. It was noted that we will be needing a new data base system later in the year as OIT is doing away with the old system. Rachel stated the cost has been estimated to be between \$10,000 to \$15,000 for the new system.
- c. New Issues/Concerns

- i. The Course guidelines for schools was presented. It was discussed where these guidelines came from and it was determined that in addition to the guidelines technology instruction and guidance needed to be added to both sections. A motion was made by Angela Dean to accept the guidelines with the mentioned addition. Bob McKinney seconded the motion. The motion passed unanimously.
- A motion was made by Dr. McKinney to accept the new supervision form and changes noted. Kai Mumpfield seconded the motion. The motion passed unanimously.
- iii. A motion was made by Dr. McKinney to change the CEU hours for students from 15 hours per semester to 5 hours per semester when enrolled in classes. This is regarding Ch. 85-x-8 5A. Kai Mumpfield seconded the motion. The motion passed unanimously.
- iv. A motion was made by Dr. McKinney to allow teachers to earn CEU's for classes they are teaching. Kai Mumpfield seconded the motion. The motion passed with Angela Dean, Nicole DeLee, and Marilyn Colson voting yes and 3 abstained. The board members that are currently professors all abstained from this vote.
