View from the Chair

I would like to extend greetings to everyone and my best wishes for 2015. In October I assumed the role of Board Chair. Regrettably at this time we said farewell to Board members James Ware and Leisa Askew, who have provided valuable leadership and insight during their terms. We will also bid farewell, to Paula Johnson once the Governor has named a replacement. Their commitment to social work and public protection, their broad knowledge, and wisdom will be missed. Special thanks to them for their volunteer service to help make Alabama a great place to practice social work. We do welcome two new Board members, LaShea Cobb-England of Tuscaloosa, and Valeri White of Opelika. We look forward to the new ideas and perspectives that they may bring.

Since I am new in the Chair position, you may want to know a little about me. The district I represent is located in Lower Alabama, and I am a Professor of Social Work at the University of South Alabama in Mobile. I am from Texas and moved to Alabama over ten years ago to build the BSW program at USA. Most of my professional experience is in administration, education and macro practice, but for five years I was a child protective services worker and supervisor.

Over the last six months the Board and its members have been active. Undoubtedly the biggest change is the approval of several changes to the Alabama State administrative Code that affect social work practice. Included among these changes are provisions for reinstatement of an expired license, addition of requirements going forward for CEUs in ethics and child abuse/neglect, revision of rules concerning license application/renewal after some types of offenses, and updating some of the language in the Code. These changes should make the Board better able to respond to the needs of licensees and the public. For those of you who have not previously done so, I also encourage you to look at our web site. It has a more contemporary look, has more features, and is easier to use.

Several Board members have also volunteered time from their busy schedules to attend continuing education provided by the Association of Social Work Boards to enhance their knowledge of licensing, testing, and regulatory issues, so that they can provide more effective service. The Board members are always mindful that they serve you and the State. It is an honor and an important responsibility to represent you. You should feel free to contact us and let us know your thoughts or concerns. Our meetings are open to the public and our minutes posted on-line. On behalf of the Board I send our best.

FAQ

- Q. Do I need to be in a social work position to obtain supervision for the LCSW?
- A. Yes, you must be in a social work position in order to receive supervision towards the LCSW. You also must have an active and current LGSW to qualify.
- Q. Since the Rules have changed about the "face to face" can I obtain my supervision through Skype or other means of visual communications?
- A. Yes, you are allowed to obtain supervision through live interactive means of visual communications. The key to this is it must be all three: live, interactive and visual.
- Q. Where can I find the supervision contract and do I need one?
- A. The supervision contracts are on our webpage under "Applications & Forms". It is best to have the contract approved in advance so that you are not wasting your time or money should the supervision not be acceptable.
- Q. Where can I find the Mandatory Child Abuse Reporting program being required by the Board?

 A. The program is made available through another site but you can link to it through the Board's at www.socialwork.alabama.gov under "CE" The link is named "Mandated Reporters Online Training"
- Q. Since we have the 60 day grace period to renew our license does this mean our license really doesn't expire until the end of the grace period?
- A. No, your license is expired during the grace period and you should not be practicing social work with an expired license. Although you do have a grace period of 60 days to renew your license it still expires the last day of the month in which it was due.
- Q. I renewed my license online and was selected for audit. Can I get a refund since I have to mail my CE to the board anyway?
- A. No, audits are random and about 20% of renewals are audited. You will not know before you start the process if you're going to be selected. The service fee for renewal online that you pay Alabama Interactive (AI) does not come to the board. The board receives the \$100 renewal fee and this is non-refundable.
- Q. When do we need to show the new mandatory CE hours?
- A. You should start getting the new required hours now and they must be on everyone's renewals by January 1, 2017 and thereafter.
