# The Alabama State Board of Social Work Examiners Board Meeting Minutes March 20, 2015

The regular meeting of the Alabama State Board of Social Work Examiners was held on March 20, 2015, at Jacksonville State University, Jacksonville, Alabama, with the Board Chair present. Secretary Jennifer Venable-Humphrey was not present at the meeting. Mandy Andrews served as Secretary.

Board Chair, Michael Daley, called the meeting to order at 9:37 a.m.

#### **Approval of Minutes:**

A copy of the minutes from the January 9, 2015 Board Meeting was distributed and reviewed. Valeri White made a motion to approve the minutes. Michael Daley seconded the motion. Both the motion and the second were withdrawn. There was a discussion of needed corrections to the minutes. Valeri White made a motion to adopt the minutes as revised by the Board. Michael Daley seconded the motion. The motion was approved unanimously.

#### Old Board Business:

- a. Brenda Holden updated the Board on the status of complaints. There are six (6) open complaints One (1) settlement to be considered by the Board; three (3) hearings, held at the last meeting, awaiting action; and two (2) complaints under investigation.
- b. The Board reviewed the listing of new licensees. Esophia Clayborn made a motion to approve the list of new licensees. Valeri White seconded the motion. The motion was approved unanimously.
- c. The Board discussed the Hearing Officer Recommendations for hearings held on January 9, 2015:

- Sandria Mosely Mandy Andrews made a motion to dismiss the complaint. LaShea Cobb-England seconded the motion. Voting in favor of the motion: Esophia Clayborn, Valeri White, LaShea Cobb-England, and Mandy Andrews. Opposed: none. Abstained: Michael Daley.
- 3. Bari Joy Williams Mandy Andrews made a motion to revoke Ms. Williams' license. The motion was withdrawn. Mandy Andrews made a motion to revoke Ms. Williams' license. Further, Ms. Williams may not be considered for reinstatement for five (5) years as per the Code. In addition to the requirements of the Code, to be considered for reinstatement, Ms. Williams must prove successful rehabilitation by a qualified substance abuse professional with no relapse. - d. The Board reviewed a settlement reached regarding the complaint against Stephanie Gillispie. Mandy Andrews made a motion to accept the agreement as written. LaShea Cobb-England seconded the motion. Voting in favor of the motion: Michael Daley, Valeri White, LaShea Cobb-England, and Mandy Andrews. Opposed: none. Abstained: Esophia Clayborn.
- e. The Board reviewed, discussed, and accepted documentation provided by Vivian (Landers) Ogle.
